The "WESTERN AUSTRALIAN POLICE" is a privately owned corporation, an agent of the Corporate State of WESTERN AUSTRALIA POLICE [ABN 91 724 684 688] you are an employee of [WAP], who is an active affiliate with the Corporate Commonwealth of Australia [ABN 122 104 616] and registered with the United States American Securities and Exchange Commission: [No. 000 080 5157. 651 and it's CIK# is 0000805157.
